(ii) Expression 'INDIA' would include as given in sub-section (1) of the section 311 of the Government of India Act 1935 British India, together with all territories of any Indian ruler, the tribal areas, and any other territories which were part of India.

# **Important Instructions to the Applicants**

## **Documents required:**

Following documents are to be submitted along with the application form for obtaining PIO card.

1. **Existing (valid) passport in original**
2. **Expired Indian passport in original**  
**OR**  
**Any 2 or more of the following documents:**
  - Photocopy of expired Indian passport
  - Letter from British Home Office confirming Indian origin.
  - Indian passport or its photocopies of parents or grand parents of the applicant.
  - Birth certificate of the applicant and of the parents or grand parents of the applicant.
  - Nationality certificates of the applicant and of the parents or grand parents.
  - School or college leaving certificates of the applicant or parents of the applicant.
3. **Those applying as spouses of persons of Indian origin should submit original passport/PIO card of the spouse and original marriage certificate.**
4. **Four recent *passport size* photographs of the applicant.**
5. ***A self-addressed special delivery envelope only if you require the PIO Card to be sent by post.***
6. **Fee of £640. This can be paid in cash or Bank draft / Postal Orders payable to the High Commission of India, London. This fee includes the processing fee of £160, which is non-refundable in case of rejection of the application.**

## **Method of application:**

Completed applications and relevant documents can be submitted in person at the High Commission between **8.30** and **12.00 hrs** during any working day.

Alternatively the applications can be sent by post to The PIO Section, Visa Department, High Commission of India, Aldwych, London, WC2B 4NA. Postal applications should be sent only by Royal Mail special delivery. For return of documents postal applications should invariably be accompanied by a self-addressed Royal Mail special delivery envelope.

## **Processing Time:**

Processing of the application normally takes 1 - 8 weeks from the date of receipt of the application. Certain cases may take more time.

## **Benefits of PIO card:**

1. A PIO cardholder does not require a visa to visit India for 20 years from the date of issue of PIO card.
2. He/she is exempt from registration if his/her stay does not exceed 6 months in India. When the stay exceeds 6 months, he/she shall have to register within 30 days with the local FRRO/FRO.
3. He/she shall enjoy parity with NRIs in respect of facilities available to the latter in economic, financial and educational fields, except in matters relating to the acquisition of agricultural/plantation properties. These facilities include
  - a) Acquisition, holding, transfer and disposal of immovable properties in India .
  - b) Admission of children in educational institutions in India under general category quota for NRIs, including medical and engineering colleges, IITs, IIMs etc.
  - c) Various housing schemes of LIC of India, State Governments and other Government agencies.
  - d) They can open bank accounts in India, which will be at par with rupee accounts.
  - e) All future benefits that would be extended to NRIs would also be available to the PIO cardholders.
