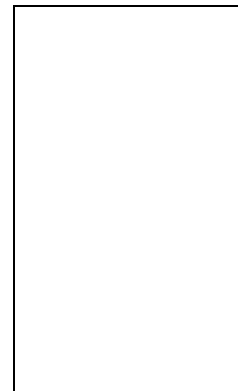
The form, duly completed in block letters may be sent to the Passport Section, High Commission of India, at the above address, or brought in person together with:

- (1) 12 recent full-face photographs of 35mm x 45mm size, one of which should be attested by either a G.P./Bank Manager/Postmaster/Solicitor/Commissioner of Oaths/Notary Public.
- (2) A strong self-addressed stamped envelope.
- (3) 'L' form duly completed.
- (4) Police report in case of lost/stolen passport.
- (5) Affidavit, duly notarised (as per specimen enclosed).
- (6) A letter from the British Home Office stating non-acquisition of British Nationality (in case you are not a visitor to this country).
- (7) Photocopy of lost passport/previous cancelled passports/documents proving stay in U.K. (N.H.S. card, driving licence, letter from Immigration Department, Home Office, bank statements etc).

The fee payable for duplicate passport is £141.00. If application is sent by post, the fee should be paid through Postal Orders payable to the High Commission of India. Applications can also be lodged at the Passport Counter, India House, between 9.30am to 1.00pm. In this case, the fee is accepted only in cash.
